KLAPTON ACT OF TERRORISM PROTECTION TABLE OF BENEFITS:

The loss caused as a result of an Act of Terrorism	What shall we pay
Death	The Protection Amount you chose for the deceased insured.
Permanent and Total Disability	120 monthly payments of 1% of the Protection Amount you chose for the injured insured.
Hospitalization	1% of the Protection Amount you chose for the injured insured for each month or part thereof in hospital – up to 120 months.

HOW MUCH PROTECTION CAN YOU BUY:

You decide what will be the Protection Amount for each of the listed insureds. The amount can be different for each insured.

You can take from 25,000 per insured and up to a maximum per insured person of 1,000,000.

HOW MUCH DOES THE KLAPTON ACT OF TERRORISM PROTECTION PLAN COST:

The annual premium is only 1.00 for each 1,000 of Protection Amount (0.10%).

Therefore, if you take 100,000 Protection Amount, it will cost you only 100 per year.
